ORDER:

In the circumstances stated by the Collector, Ranga Reddy District and the Commissioner of Land Revenue in their letters second and third read above, the Government hereby order that an extent of Ac.60.00 of Government land situated in Sy.No.74 of Gopannapally village, Serilingampally Mandal, Ranga Reddy District be alienated in favour of Journalists Cooperative Housing Society Ltd., on payment of a concessional value of Rs.18,000/- (Rupees eighteen thousand only) per acre in relaxation of ban orders issued in G.O.Ms.No.1409, Revenue, dt.19-8-78.

2. The value realised shall be credited to the Head of Account "0029 - Land Revenue - 107 - Sale proceeds of the waste lands and resumption of land tax - 81 - other item" and the fact of the credit should be intimated to Government.
