CONCESSION IN THE REGISTRATION CHARGES TO REGISTER THE PLOTS BY JOURNALISTS CO-OPERATIVE HOUSING SOCIETY LIMITED, HYDERABAD IN FAVOUR OF ITS MEMBER ALLOTTEES AT PHASE-III.

I. In exercise of powers conferred by clause(a) of sub-section(1) of section 9 of Indian Stamp Act, 1899 (Central Act.II. of 1899), the Governor of Andhra Pradesh hereby directs that the Stamp Duty is payable based on the value of Rs. 18,000/- per acre (which was the price fixed by the Government at the time of alienation of land) in respect of the Documents relating to the transfer of plots to be got registered by the Journalists Co-operative Housing Society Limited, Hyderabad in favour of its member allottees at Phase-III, Journalists Colony in Survey No.74 at Gopannapalli Village, Serilingampally Municipality, Ranga Reddy District.

II. In exercise of the powers conferred by Section 78 of the Registration Act, 1908 (Central Act XVI of 1908), the Governor of Andhra Pradesh hereby makes the following amendment to the "Table of Fees" under Registration Fees issued in G.O.Ms.No.757, Revenue (Regn.I) Department, dated the 18th December, 2001 and published at pages 1 to 10 of Part I of Extraordinary issue of the Andhra Pradesh Gazette dated the 20th December, 2001 and as amended from time to time.
